Please be advised that a Compliance Audit Committee Meeting has been scheduled for **Thursday, July 7, 2011 at 10:30 a.m. in the Grimsby/Lincoln Room, District School Board of Niagara Education Centre, 191 Carlton Street, St. Catharines, Ontario** to consider the Application for a Compliance Audit received for a compliance audit of Lynn Campbell's election campaign finances for the October 25, 2010 election, a copy of which is attached hereto.

The reason for the Application is as follows:

“It appears that the District School Board of Niagara contributed to the election campaign in violation of the Municipal Elections Act to the benefit of the candidate's campaign, and the candidate did not declare the contribution.”

Pursuant to the Procedures of the Niagara Compliance Audit Committee, a copy of which is attached hereto, please be advised of the following.

Under Section 8 of the Procedures, the Applicant and the Candidate have the opportunity to submit any and all documentation to the Board Secretary at least seven (7) days prior to the meeting for distribution to the parties in advance of the meeting. The Candidate may respond to the application in writing and same shall be submitted to the Secretary of the Board at least four (4) days prior to the meeting for circulation with the Agenda.

Therefore, we must receive the Applicant's disclosures by **June 30, 2011**. The Candidate will have until **July 3, 2011** to respond in writing and submit same to the Secretary of the Board.

The Agenda for the meeting will be circulated on **July 4, 2011**. Meetings of the Compliance Audit Committee are open to the public.

Please ensure you familiarize yourself with the Procedures of the Niagara Compliance Audit Committee in advance of the meeting.

A copy of the candidate's Financial Statement – Auditor's Report (Form 4) is attached for your reference.

If either party fails to attend the meeting the Committee may proceed in the party's absence and the party will not be entitled to further notice in relation to the meeting.

AFFIDAVIT OF JOHN PULA

I, JOHN PULA, of the City of St. Catharines in the Province of Ontario, MAKE OATH AND SAY/AFFIRM:

1. I was a candidate for the District School Board of Niagara Trustee ("DSBN") in the Municipal election held on October 25, 2010. As such, I have knowledge of the matters hereinafter deposed to, save and except those expressed to be on belief.
2. I was named in a campaign flyer, along with Alex Bradnam, Linda Crouch and Paolo Miele that was circulated throughout St. Catharines and Niagara-on-the-Lake near the end of the campaign period ("Flyer"). Attached as Exhibit "A" to this my Affidavit is a copy of the Flyer.
3. The four candidates named on the campaign flyer were all endorsed candidates by the Niagara Regional Labour Council.
4. The Flyer contained statements that were apparently untrue and incorrect.
5. To the best of my knowledge, the Flyer apparently was included as an insert in The St. Catharines Standard on Saturday October 23, 2010.
6. I did not authorize anyone to include my name or to prepare the Flyer. I have no knowledge of who prepared it, made photocopies, or of who circulated it.


7. I have made enquiries as to where the Flyer came from but have not been successful in obtaining this information.
8. A second flyer ("Rebuttal Flyer") rebutting the statements in the said campaign flyer appeared at a DSBN School Trustee Candidate's Forum held on Thursday October, 21, 2010 in Niagara-on-the-Lake.
9. DSBN Trustee Lynn Campbell handed this Flyer to me at the said event. An original of the said Rebuttal Flyer is attached as Exhibit "B" to this my Affidavit.
10. The statements in the Rebuttal Flyer match the statements attributed to DSBN staff in a newspaper article attached as Exhibit "C" to this my Affidavit.
11. No candidate's name(s) appear on the Rebuttal Flyer.
12. At the Candidates' Forum October 21, 2010, a large stack of approximately 200 Rebuttal Flyers was prominently situated on a table for the candidates' promotional literature.
13. To the best of my knowledge and belief, since no candidate's name was on the Rebuttal flyer, it appears to me that the DSBN prepared the Rebuttal Flyer and provided the photocopies to the incumbent trustees.
14. The two other incumbent DSBN trustees being Dalton Clark and Lora Campbell were also at the event and I believe they were aware of the rebuttal flyer as the flyer was the main topic prior to the event starting.

15. Also at the event, several DSBN staff were present and I observed that they videotaped the event.


16. I believe that the presence of both Flyers (Exhibits "A" and "B") had an effect on the outcome of the election for School Board Trustee for myself and the other candidates named in the Flyer.

Correcting Mis-Information about DSBN from the October 19th NOTL Public Meeting

The Public School Board Trustees control \$500 Million of our Tax Dollars

- The DSBN 2010/11 Budget is approximately \$380 Million (\$379,859.752)

17 more schools are slated to close. Current trustees have chosen to wait until after the election to announce this.

- There are no schools "slated" for closure.

School closures do not happen by announcement. Declining enrolment is an issue that trustees across Ontario must deal with. The DSBN currently has 5,328 elementary and 5,644 secondary surplus classroom spaces – a total of 10,972 excess spaces across the region. This issue will have to be dealt with by the new Board. The process to close a school is a long one with many opportunities for public consultation through an Accommodation Review (ARC) process.

- The price of Crossroads property was \$1,479,815. This information is available to the public through the Land Registry Office. The value of the current Col J Butler and Virgil P.S. properties, along with the NDSS property, will more than offset the cost to build the new school.

***\$12 million spent on school with a declining enrolment*

- During the ARC process we reported that \$805,395 was spent at NDSS on Facility Renewal Projects from 1999/2000 to 2006/07. Good Places to Learn funding could not be spent on NDSS because the Ministry had directed boards to only use these funds on schools that would remain open for 10 years. Given the 1999 recommendations regarding NDSS, it was not possible to complete projects under the Good Places to Learn initiative at that school.

Since September 2007, the Board has spent \$340,325 on Facility Renewal Projects at NDSS.

For the same period of time for St. Catharines Collegiate, \$2,378,158 was spent on Facility Renewal Projects and \$10,185,600 was funded by the Ministry of Education under the Good Places to Learn initiative.

The Ministry provides top-up funding to recognize the higher per pupil costs of heating, lighting, cleaning and routine maintenance for schools where enrolment is less than the capacity of the school. Given this was the case with NDSS, the top-up funding was used for these purposes. In addition, since the Ministry funding formula did not generate enough revenue to fully fund the vice principal position and the secretarial staff at NDSS, the top-up funding was also applied to those expenditures.

\$240,000 spent on an entranceway to DSBN headquarters while Special Education and other programs are being cut.

- The new entrance for the Ed Centre was approximately \$240,000. This funding had been set aside many years previously as part of the original construction and kept in reserves.

DSBN builds schools in Vietnam and other places around the world with our money, while closing our schools, laying off teachers and support staff.

- The DSBN did not build a school in Vietnam or anywhere outside the Board. The DSBN has a business contract with the Canadian International School (CIS) in Vietnam. This school was funded and built by a privately owned company Khoi Nguyen Transportation and Joint Stock Trading Company from Ho Chi Minh City. This is a revenue generating agreement that saw the DSBN receive approximately \$200,000 to act as consultants to the corporation that built the school.

Trustees collect enrolment commissions based on the number of students in their area.

- Trustees are paid an honorarium which includes a flat fee plus an enrolment amount. This is in line with guidelines set by the Ministry of Education. The enrolment amount is based on total DSBN students. Given that enrolment has been declining, the Trustee honorarium has also been declining over the last 4 years.

Trustees allowed DSBN staff to be \$1,200,000 over budget on busing alone

- The DSBN had always been generous in providing courtesy busing to students across the region wherever possible. When NSTS came into existence, it was necessary to align our transportation policies with NCDSB. An efficiency and effectiveness review identified the need to alter bus routes and discontinue courtesy busing which resulted in savings to the transportation budget.

Campaign flyer raises questions

The District School Board of Niagara is wasting no time responding to a flyer that the board's vice chair alleges is "full of lies". The flyer in question was placed on the windshield of visitors' cars during the Niagara-on-the-Lake Chamber of Commerce's debate held at Virgil Public School on Tuesday night.

It features nine bulleted points about the DSBN's spending habits and board practices, and tells readers to "vote for change" by voting for trustee candidates Alex Bradnam, Linda Crouch, Paolo Miele and John Pula. None of the candidates, however, are claiming responsibility for the flyer and one in particular is upset over it.

Bradnam said he is upset that someone would distribute something with his name on it, implying it's his views, without his consent.

Incumbent trustee candidate and current vice chair on the board, Lynn Campbell was at the meeting and immediately contacted The Crier about the flyer. She said she thought it was horrible someone would spread such misinformation so close to the election date.

"It doesn't give us much time to respond and set the record straight," she said.

Brett Sweeney, media relations officer with the DSBN sent an email to The Crier clarification of seven of the nine points.

In it, he clarifies that no schools are slated for closure and that they do not happen by announcement but rather through an Accommodation Review process.

The new Crossroads property, was purchased for \$1,479,815, not the \$4-million cited in the flyer. Perhaps the most contentious and one oft repeated throughout the election is the statements regarding the DSBN school in Vietnam.


Sweeney said they did not build the one in Vietnam or anywhere outside of the board. They have a business contract with the Canadian International School in Vietnam but the school was funded and built by a privately owned company. The contract is a revenue generating agreement which saw \$200,000 go to the DSBN for acting as consultants.

Trustees, he said, are paid an honorarium of a flat fee and an enrolment amount which is based on total DSBN students, not restrictive to their area like the flyer claims.

Over an eight-year period the DSBN spent \$11 million at St. Catharines Collegiate, with over \$10 million of that coming from the Ministry of Education. Sweeney said it's important to consider the context of 'spending money on schools with declining enrolment' like the flyer states, considering enrolment is declining across the board. It's not a justification, he said, to stop spending money in them.

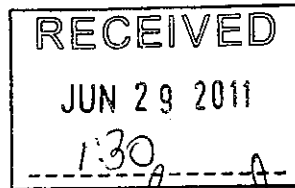

Regarding the Campaign Audit Request filed by John Pula of Dalton Clark, Lora Campbell and Lynn D. Campbell

I was a candidate for English Language Public School Board Trustee for the District School Board of Niagara (DSBN) for St. Catharines and Niagara-on-the-Lake in the October 25, 2010 municipal election.

I was named in a Campaign Flyer (along with Alex Bradnam, Paolo Miele and John Pula) that was apparently circulated throughout St. Catharines and Niagara-on-the-Lake near the end of the campaign period, according to an article in Niagara This Week.

The four candidates named on the campaign flyer were the four trustee candidates endorsed by the Niagara Region Labour Council for our area.

I received a copy of the campaign flyer in my copy of The Standard as an ad insert in the Saturday October 23, 2010 edition.

I did not authorize anyone to prepare the flyer, and I have no knowledge of who prepared it, made photocopies, or who circulated it.

The flyer makes a number of incorrect statements.

My lawyer and I have each made enquiries to The Standard as to where the said flyer came from but have been unsuccessful apparently due to privacy legislation. My first enquiry was made to The Standard on Election Day before the results were in. I also filed a report with the Niagara Regional Police about it.

On Thursday October 21, 2010 at the DSBN Trustees Candidates Event at the Community Centre in Niagara-on-the-Lake, I arrived about 30 minutes before the event started. I walked in shortly after Dalton Clark and Lynn Campbell, whom I saw meet in the parking lot ahead of me and they walked in together.

After I walked in, I saw a large stack of yellow flyers on the allotted table for campaign literature.

When I entered the event, Dalton Clark and Lynn Campbell were standing together about 2 feet away from the campaign literature table, facing the table.

The stack was the largest on the table and was on yellow paper.

The yellow flyer made the same points as a Niagara This Week article where DSBN staff Brett Sweeney was quoted correcting claims in the campaign flyer.

In the half hour prior to the event starting, the yellow rebuttal flyer was the talk of the event and I observed discussion of it among the candidates.

Immediately prior to the event starting, Lynn Campbell, Dalton Clark and I had a discussion about the rebuttal flyer's contents while we were seated at the head table.

The DSBN had shown interest in the St. Catharines and Niagara-on-the-Lake election. I first noticed this starting on September 29, 2010 at Trustee Candidates Event in St. Catharines. Several DSBN staff were in attendance including DSBN superintendents and Karen Bellamy who is the Administrative Assistant to the Director Warren Hoshizaki. They sat in the seats directly facing me and the incumbent candidates due to alphabetical seating of the candidates.

The DSBN staff members also attended the Thursday October 21, 2010 Candidates Event in Niagara-on-the-Lake, including Brett Sweeney, Kim Yielding, Marian Lamb (Executive Assistant to DSBN Director Warren Hoshizaki) and Superintendent Linda Kartasinki. The group again sat directly in front of me and the incumbent trustees.

I observed the meeting being videotaped by a camera on a tripod located immediately beside the DSBN staff.

I believe the campaign flyer and the rebuttal flyer both had an effect on the election,

I respectfully suggest that the Campaign Audit Committee could investigate the Campaign Flyer and discover if the photocopying and advertising costs were claimed on the financial statements of any candidates, such investigation being allowed under Section 93 of The Municipal Elections Act.

I make this statement for no improper purpose.



1. Exhibit B, the flyer produced by the DSBN to clear up the miscommunication in Exhibit A, had nothing to do with me. I did not write it. It did not have my name on it. It did not promote me or help me to get elected.

Ironically, I did not even get elected! The charges by Mr. John Pula leading to this audit are totally bogus.

The sole purpose of Exhibit B was to correct lies about the DSBN on the flyer known as Exhibit A. The purpose of Exhibit B was not to endorse or promote me or any other candidates.

Yes, I handed a copy of Exhibit B to John Pula. Why? I was trying to do him a favour. It was my attitude that it is important for candidates to have all of the facts. As a former newspaper reporter, I am oriented towards telling the truth. Obviously I did not give Mr. Pula this flyer because I thought it would motivate him to vote for me, since he was running against me! I'm sure that he already planned to vote for himself, not me!

Also, I was brought up in a family and a church which valued "truth." Lies offend me morally and ethically.

Exhibit B was not part of my campaign promotional material; it was a DSBN document designed to counteract the misinformation in Exhibit A. I had my own brochures which I bought and paid for with my own money. I do not take campaign donations from anyone because I do not want anyone to "own" me, or think they can influence my decisions as a trustee.

Exhibit A's origins remain a mystery. Four candidates were named and promoted through Exhibit A. Did these candidates credit the producer of Exhibit A with contributing to their campaigns in their financial statements? If so, then we could solve the mystery of who put out Exhibit A! Did the erroneous information in Exhibit A hurt the reputation of the DSBN and hurt the chances of incumbent candidates and help the candidates named on Exhibit A, as seemed to be its purpose? Did Exhibit A or Exhibit B help or hurt any of the candidates' election chances? That is the real issue. With 13 candidates running, there were so many different factors and reasons why some emerged victorious and others were losers. In my opinion, it is much more likely that Exhibit A hindered my chances, then the scenario that Exhibit B helped my chances, for re-election.

In closing, Exhibit B was NOT a tool designed to assist with my election campaign, and therefore not a "benefit" to me which should have been listed in my election contributions, and therefore, the accusations which led to this audit are false and unfounded.
